ESSA – Goals for States

- 95% participation on assessments
 - Required for Title I funding
- Only 1% may take alternate tests
- States may assess other subjects

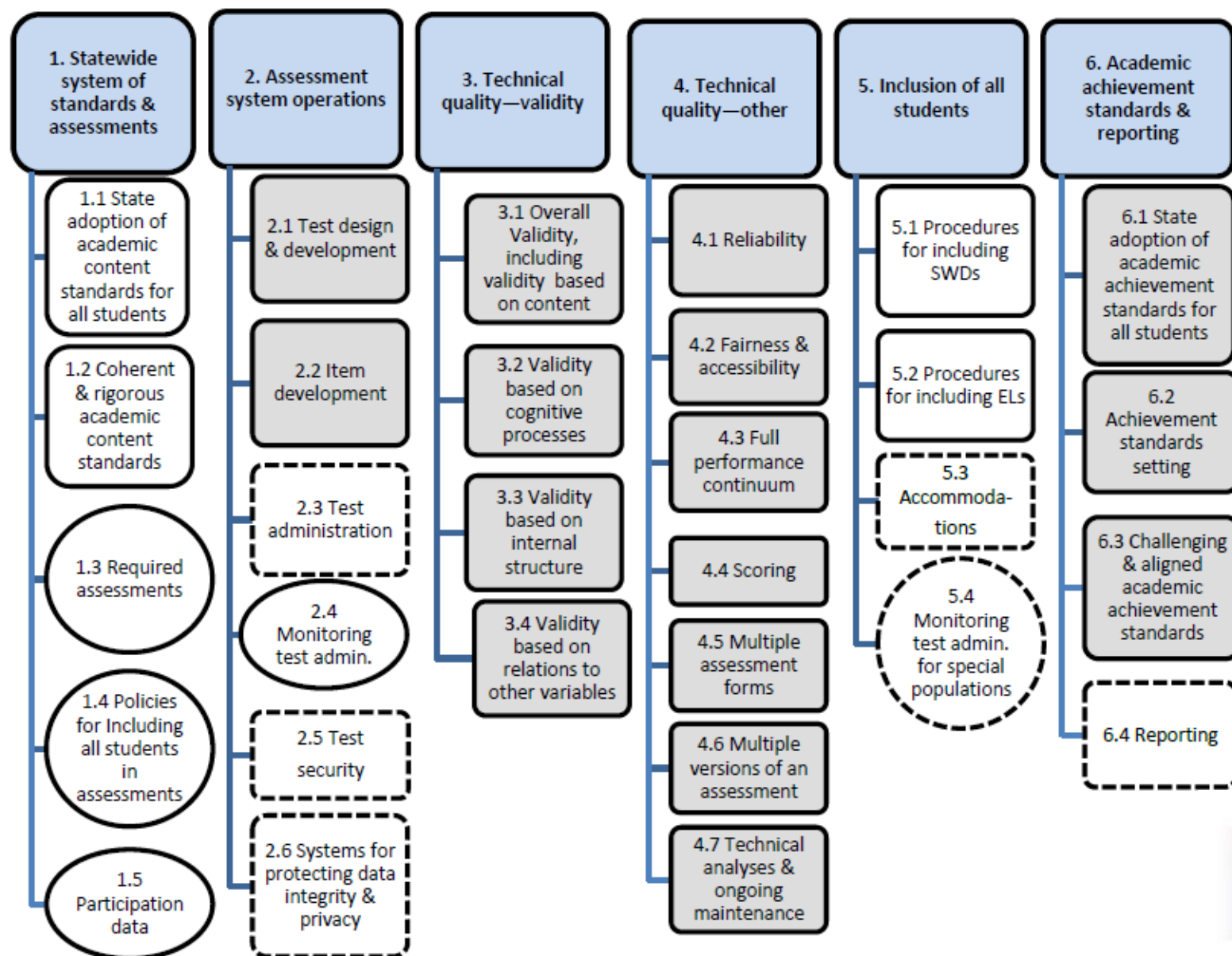
ESSA – Goals for States

- Must adopt challenging academic standards
- Math & reading/ELA assessed in grades 3-8 & once in grades 9-12
- Science assessed at least once in grades 3-5, 6-9, and once 10-12

ESSA Peer Review

- Assessment peer review is the process through which a State documents the technical soundness of its assessment system. State success with its assessment peer review begins and hinges on the steps a State takes to develop and implement a technically sound State assessment system.
- The OSDE Office of Assessments submitted over 8,000 pages of evidence to the USED in January of 2018.

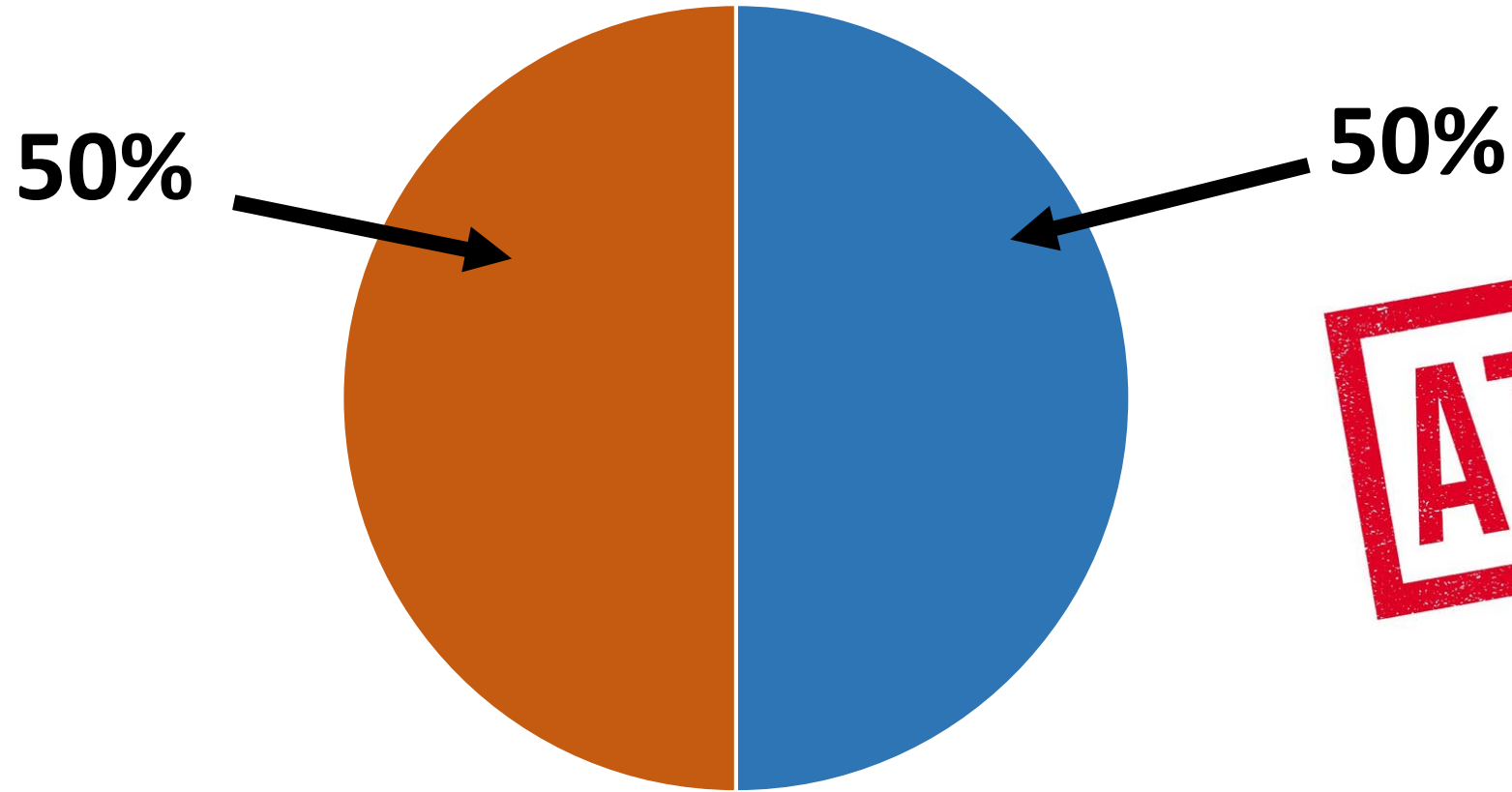
For 2018-19, Students in Grade 11 will take the following assessments:

- ACT/SAT + writing (ELA/Math)
- Grade 11 Science Content
- Grade 11 U.S. History (HB 3311)

HB 3311 U.S. History requirements

- The subject matter standards for United States Government shall include an emphasis on civics. For the purposes of this section, "civics" means the study of the rights and duties of Oklahoma and United States citizens and of how those governments work.
- United States History assessment, with an emphasis on civics, not less than once during the grade span of nine through twelve.

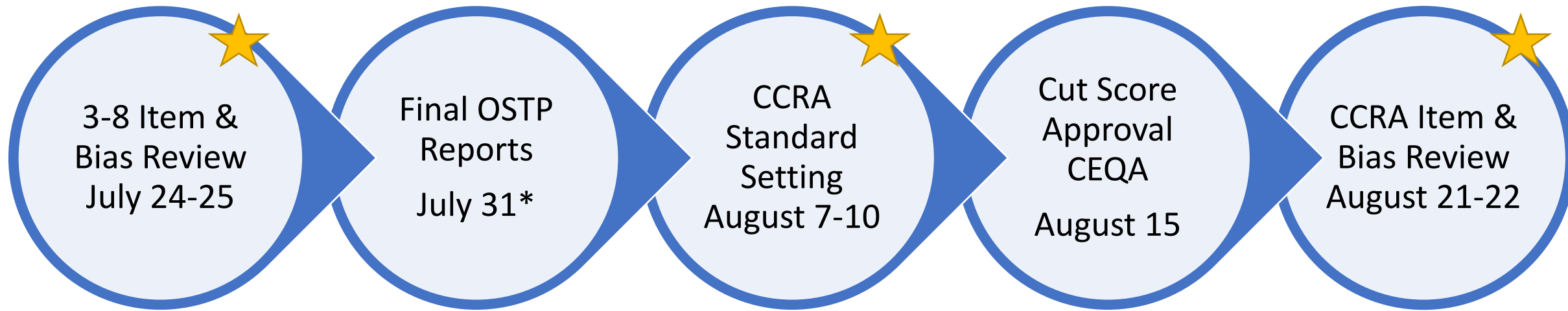

SB 1197: Performance Levels

Previously	This Year and Beyond
Advanced	Advanced
Proficient	Proficient
Limited Knowledge →	Basic
Unsatisfactory →	Below Basic



SB 1197: Performance Level Definitions

- Advanced, which shall indicate that students demonstrate superior performance on challenging subject matter;
- Proficient, which shall indicate that students demonstrate mastery over appropriate grade-level subject matter and challenging grade-level subject matter, can analyze and apply such knowledge to real-world situations, that students are ready for the next grade, course, or level of education, as applicable and that students are on track to be ready for college or career;
- Basic (Limited Knowledge), which shall indicate that students demonstrate partial mastery of the essential knowledge and skills appropriate to that are foundational for proficient work at their grade level or course and that students are not on track to be ready for college or career
- Below basic (Unsatisfactory), which shall indicate that students have not performed at least at the limited knowledge basic level.

OSTP 3-8 Parent Portal

- The Oklahoma Parent Portal is designed to provide students, parents with online access to a student's state assessment scores.
- It will assist a student and his or her parents with tracking assessment information throughout the student's academic career.
- The portal provides scores for the OSTP 2017 and 2018 assessments.

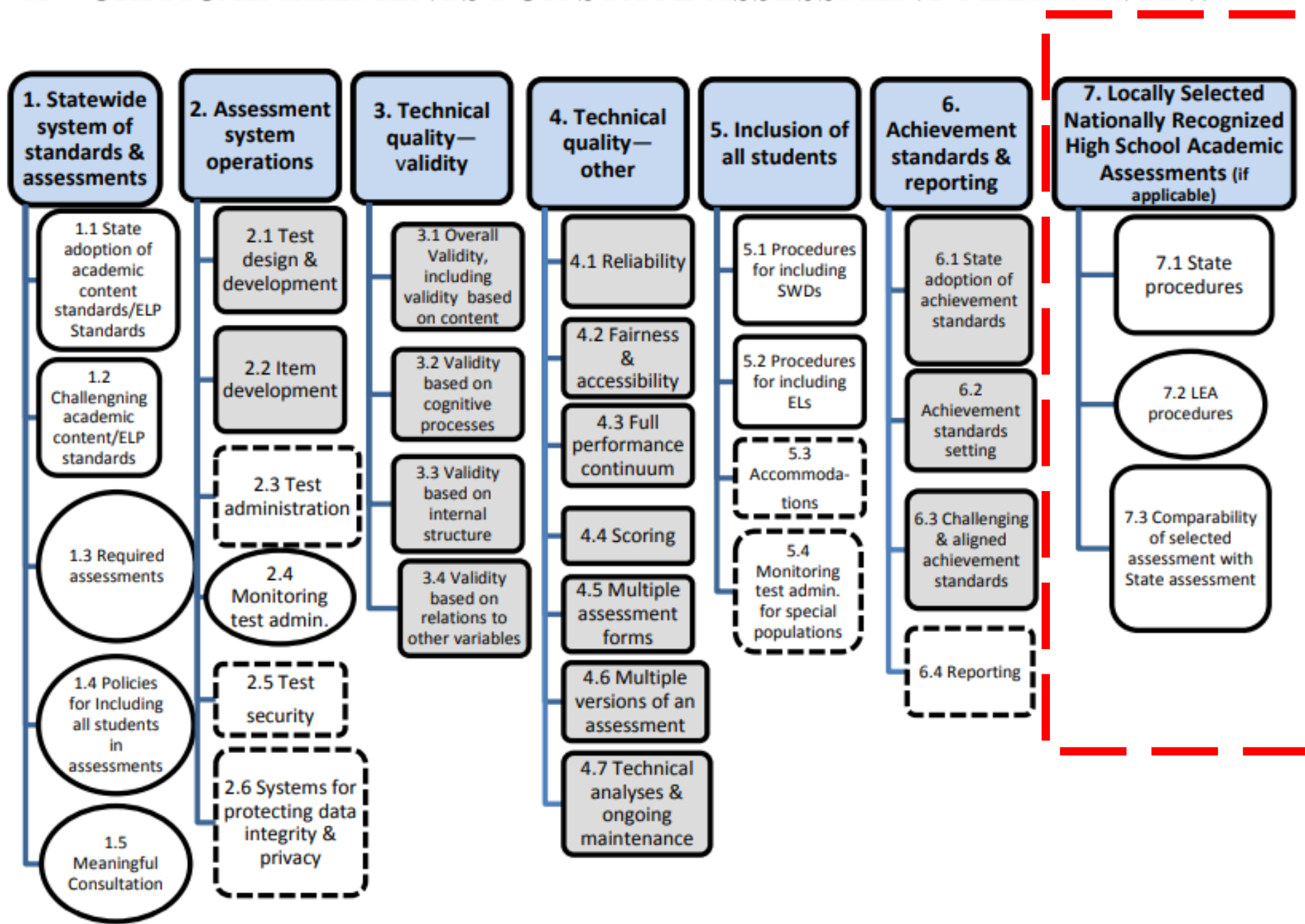
CCRA District Choice

- ESSA requires states to administer the same academic assessments to measure the achievement of all public elementary school and secondary school students in Oklahoma.
- Districts will have the opportunity to choose either the SAT or ACT to meet the accountability requirements for high school ELA and mathematics.

Critical Element 7.2

- The State must have procedures in place to ensure that:
Before a district requests approval from the State to use a nationally-recognized high school academic assessment, the district notifies all parents of high school students it serves.
 - That the district intends to request approval from the State to use a nationally recognized high school academic assessment in place of the statewide academic assessment.
 - Of how parents and, as appropriate, students may provide meaningful input regarding the district's request.
 - Of any effect of such request on the instructional program in the district.

HB 3221: Transition to Online Assessments

- HB 3221 requires the administration of an electronic delivery system for the OSTP.
 - Reporting, administration, and cost efficiencies
- Directs the State Board of Education (SBE) to adopt a timeline for full implementation.
 - Pending SBE approval
- OSDE is available to assist districts with this transition.

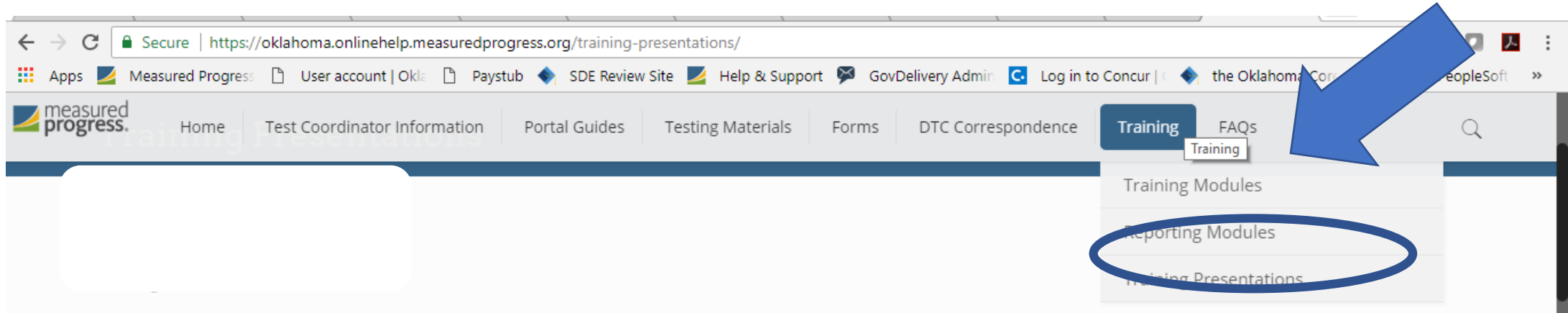

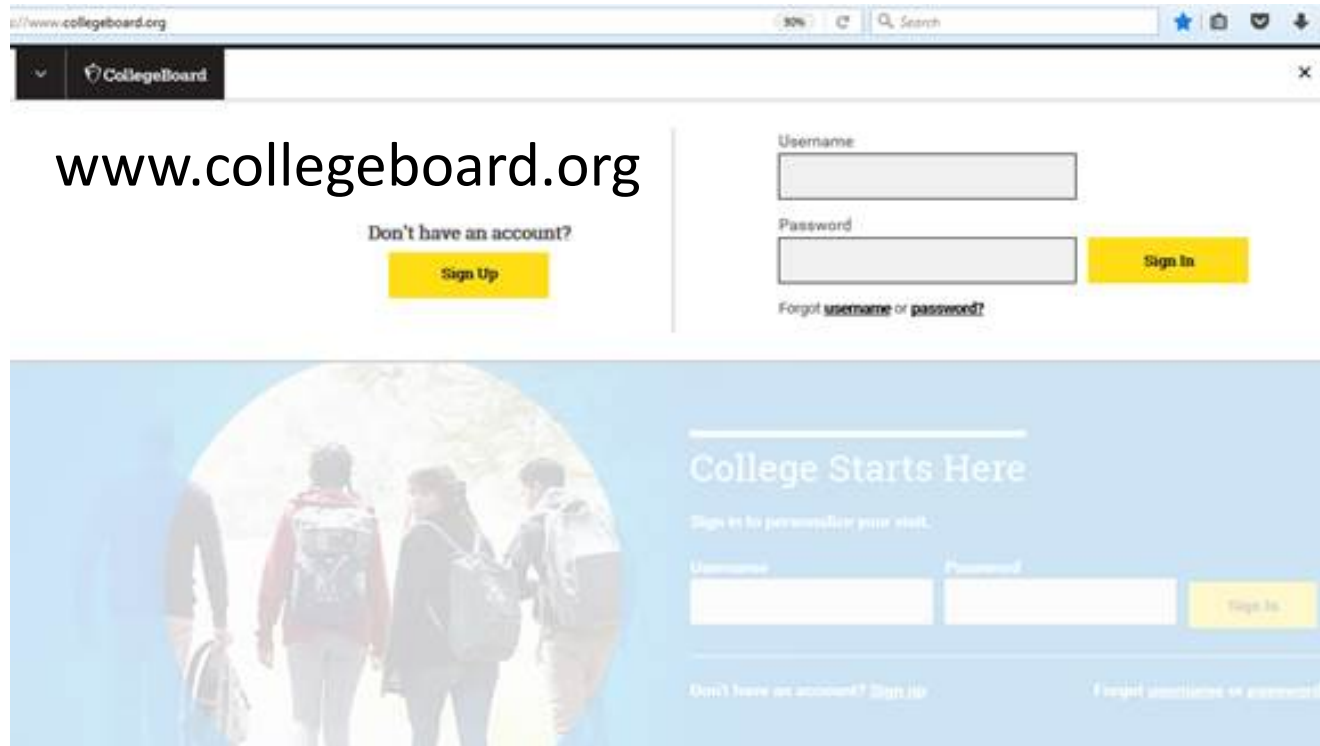


Grade 11 Science Content

- 2017-18 Grade 11 Science Content was a field test that will only be calculated in the participation for accountability (95%)
 - 2018-19 Grade 11 Science Content will be an operational test that will be calculated in both participation and student achievement metrics
- No individual student reports will be provided
- Districts and schools* will receive percentiles and rankings
 - A spreadsheet located on the Measured Progress SFTP will provide the percentiles and rankings by district and school

*Schools with an insufficient n-size will not receive percentiles or rankings
